## MEMORANDUM OF UNDERSTANDING

The first party here in represents and states that he has been accepting Mid-Day Meals from the second party for the past recognizable period where in, the Mid Day Meals and services of the second party is satisfactory. Hence, the first party inclines to get the Mid Day Meals services for the period from 2013 – 2014 from the second party here in. Thereby, the second party has agreed to the request of the first party here in to continue the Mid-Day Meals services as usual.

The first party represents that he would not entertain any outsiders in the school premises in respect of Mid-Day Meals.

The Mid Day Meals shall be served for children who are studying from I<sup>st</sup> Std. to IV<sup>th</sup> Std.

The second party further states that he renders services of the Mid-Day Meals in association with the State and Central Governments.

The first and the second party shall go in understandings and co-operations with each other without any malice in minds in so far as the Mid-Day Meals programme is concerned in the interest of young children in order to prevent the dropouts from education.

Further, the first party represents that he would not break the services in the middle abruptly in a manner to starve the stomachs of the dependents.
